AN ORDINANCE ADOPTING A SCHEDULE OF FEES AND CHARGES FOR VARIOUS
SERVICES, LICENSES AND PERMITS FOR THE CITY OF BIGFORK, MINNESOTA.

The City Council of the City of Bigfork, Minnesota, ordains:

Section 1. The following are the fees and charges for the permits, licenses and services listed below which are referenced to the section of the city code which authorizes their establishment:

PUBLIC WORKS FEES

The sewer service rates and charges to users of the Sanitary Sewer System pursuant to § 51.48 (A) shall be as follows:

The water service rates and charges to users of Water System pursuant to § 52.36 (A) shall be as follows:

1.5	\$62.18	\$6.95
2	\$100.18	\$6.95

The rates and charges for users of the Street Lighting System pursuant to § 53.10 (A) shall be \$4.00 per month.

The rates and charges for non-resident commercial users of the Sanitary Sewer and Water System pursuant to § 51.47 and § 52.36 (A) shall be fifty percent (50%) higher than the rates listed above.

The rates and charges for non-resident residential users of the Sanitary Sewer and Water System pursuant to § 51.47 and § 52.36 (A) shall be fifteen percent (15%) higher than the rates listed above.

The connection fee for new sanitary sewer services pursuant to § 51.47(B) shall be \$500.

The connection fee for new water services pursuant to § 52.12 shall be \$500 which includes the cost of the water meter at the time of installation.

The reconnection fee for an existing water service that has been temporarily discontinued pursuant to § 52.20 (B) shall be \$85.00.

The permit fee for repair or replacement of an existing connection pursuant to § 51.42 (E) or § 52.32 (E) shall be \$50.00.

The charge for replacement, repair, or adjustment of any meter pursuant to 52.18(C) shall be the actual cost of the replacement, repair or adjustment necessary.

The charge for meter testing pursuant to § 52.18(G) shall be \$25.00.

The water service rate per 1,000 gallons of water for use of water from fire hydrants pursuant to § 52.32 (F) (4) shall be \$5.00.

The meter rental charge for use of water from fire hydrants pursuant to § 52.32 (F) (4) shall be \$25.00.

The application fee for a private wastewater system pursuant to § 51.43 shall be \$25.00.

The license fee pursuant to § 51.44 (E) and § 52.32 (E) shall be \$25.00.

The fee for non-emergency Public Works service after posted hours pursuant to § 51.47 (H) and § 52.36 (I) shall be \$150.00.

The charge for new customers entering the water and sewer utility system as the result of purchasing or renting a home with an existing water and sewer connection pursuant to § 51.48 (B) and § 52.36 (B) shall be twenty five (\$25.00) dollars, payable upon application for said service.

The fee for an Excavation Permit pursuant to § 54.03(A)(1) shall be \$48.00.

The fee for an Obstruction Permit pursuant to § 54.03(A)(2) shall be \$30.00.

The fee for a right-of-way permit extension pursuant to § 54.03(B) shall be \$12.00.

The delay penalty pursuant to §54.03(C) shall be \$36.00 with an additional \$10.00 charge per day for each day over the 3rd day late.

SYNTHETIC DRUG ESTABLISHMENT FEES

The license fee for a synthetic drug establishment pursuant to § 113.06 shall be \$1,500.00 per year.

ADULT ORIENTED BUSINESS FEES

The license fee for an adult oriented business pursuant to § 117.08 shall be \$2500.00 per year.

CEMETERY LOT FEES

The fee for cemetery lots pursuant to § 170.03(A) and § 30.11 shall be \$200.00 for residents of the City and \$350.00 for non-residents.

The fee for recording of cemetery deeds pursuant to § 170.03(D) shall be \$50.00 per sale.

LAND USE/ZONING PERMIT FEES

The fee for a land use permit pursuant to §150.03(B)(12)(a) shall be \$60.

The fee for a conditional use permit pursuant to §150.05(H)(2) shall be \$150.00

The fee for a variance application pursuant to §150.04(D)(1) shall be \$150.00

The fee for a sign permit pursuant to §150.08(H)(1) shall be \$30.00

LIQUOR LICENSE FEES

The fee for a 3.2 percent malt liquor on-sale liquor license pursuant to § 111.22(A) and § 111.23(B) shall be \$75.00.

The fee for a 3.2 percent malt liquor off-sale license pursuant to § 111.22(B) and § 111.23(A) shall be \$75.00.

The fee for a Temporary 3.2 percent malt liquor license pursuant to § 111.22(C) and § 111.23(A) shall be \$10.00 per day.

The fee for an Off-sale intoxicating liquor license pursuant to § 111.22(D) and § 111.23(A) shall be \$100.00.

The fee for an On-sale intoxicating liquor license pursuant to § 111.22(E) and § 111.23(A) shall be \$1500.00.

The fee for a Sunday on-sale intoxicating liquor license pursuant to § 111.22(F) and § 111.23(A) shall be \$200.00.

The fee for a Combination on-sale/off-sale intoxicating liquor license pursuant to § 111.22(G) and § 111.23(A) shall be \$1600.00.

The fee for a Temporary on-sale intoxicating liquor license pursuant to § 111.22(H) and § 111.23(A) shall be \$10.00 per day.

The fee for an On-sale wine license pursuant to § 111.22(I) and § 111.23(A) shall be \$250.00.

The fee for a One day consumption and display permit pursuant to § 111.22(J) and § 111.23(A) shall be \$10.00 per day.

The fee for the approval of the issuance of a consumption and display permit by the Commissioner of Public Safety pursuant to § 111.22(K) shall be \$300.00.

ANIMAL FEES

The fee for reclaiming an impounded animal pursuant to § 90.04(C) shall include and cover all of the following:

- The hourly wage of the City employee for actual time spent impounding, caring for, and transporting the animal
- Reimbursement for actual miles driven at the current IRS mileage reimbursement rate
- All fees charged by the pound for boarding and care of the animal

MISCELLANEOUS FEES

The fee for copies of information provided pursuant to a public records request when the requester is not the subject of the data shall be \$0.25 (twenty-five cents) per printed page for paper copies for any request for which the final product is 100 pages or less, payable before distribution of the requested documents.

The fee for copies of information provided pursuant to a public records request in all other circumstances shall represent the actual costs to fulfill said request that the State of Minnesota permits municipalities to collect, payable before distribution of the requested documents.
